**27 FEV. 2025** OPEN INTERNATIONAL CALL FOR TENDERS N° **0057** AOIO/PAK/CIPM/2024 OF TO SUPPLY CRITICAL EQUIPMENT TO SECURE THE DISTRIBUTION OF ELECTRICITY FROM THE MBORO THERMAL POWER STATION IN TWO (2) LOTS.

**FUNDING:** Budget of the Port Authority of Kribi. 2025, 2026 and 2027 FYs.

## 1. PURPOSE OF THE CALL FOR TENDERS

With a view to reinforcing the resilience and safety of the electrical facilities serving the Port, and in order to ensure a stable and reliable power supply for port activities, the General Manager of the Port Authority of Kribi, Project Owner, hereby launches a Call for Tenders to supply critical equipment to secure the distribution of electrical power from the Mboro thermal power station in two (2) lots:

- ❖ **LOT 1:** Supply of HTA/BT transformers to secure the intramural distribution of electrical energy
- ❖ **LOT 2:** Supply of a synchronoscope, for the coupling of generators, DC control cabinet, batteries and protection relays for HVA cells.

## 2. NATURE OF SERVICES

Services covered by this Call for Tenders shall include:

### LOT 1:

- ❖ Supply of a 500KVA 10KV/0.4KV transformer;
- ❖ Supply of a 1600 KVA 10KV/0.4 KV transformer;
- ❖ Transformer testing and measurement;
- ❖ Capacity-building for transformer operation and maintenance staff;

### LOT 2:

- ❖ Supply, configuration and installation of Caterpillar EMCP 3.5 synchronoscope;
- ❖ Supply of GNZ 100, 100A batteries;
- ❖ Supply of a battery analyser;
- ❖ Supply, configuration and installation of HV cell protection relays: REF 615 and RET 615;
- ❖ Supply, configuration and installation of the TAPCON 230 controller;
- ❖ Training of staff in the installation, maintenance and operation of the synchronoscope, battery analyser, charge regulators and REF and RET relays.

Details on supplies shall be provided in the Supply Description.





### 3. PART/ALLOTMENT

This Call for Tenders shall be divided as follows:

- ❖ LOT 1: Supply of MV/LV transformers to secure the intramural distribution of electricity.
- ❖ LOT 2: Supply of a synchronoscope, for the coupling of generators, DC control cabinet, batteries and protection relays for HVA cells.

### 4. PROVISIONAL COST

The provisional cost of the operation after prior studies is one hundred and ninety million (190,000,000) CFAF all tax inclusive broken down as follows:

- ❖ LOT 1: Ninety million (90,000,000) CFAF all tax inclusive ;
- ❖ LOT 2: One hundred million (100,000,000) CFAF all tax inclusive.

### 5. PROVISIONAL EXECUTION TIME AND PLACE OF DELIVERY

The maximum execution time provided for by the Project Owner to provide the services covered by this Call for Tenders shall be six (6) months for each lot.

This period shall run from the date of notification of the service order to start work.

The place of delivery shall be the site of the Port Authority of Kribi in Kribi following the 2022 incoterm Delivery Duty Paid (DDP).

### 6. PARTICIPATION AND ORIGIN

This Call for Tenders is open to national and international companies with proven experience in supplying such equipment.

### 7. FUNDING

Services covered by this Call for Tenders shall be funded by the Budget of the Port Authority of Kribi, 2025, 2026 and 2027 FYs.

## 8. SUBMISSION MODE

The submission mode chosen for this Call for Tenders is offline mode.

## 9. BID BOND

Bids must be accompanied by a bid bond issued by a financial institution approved by the Minister in charge of finance to issue bid bonds for public contracts (see Document 15 in the Tender File) and amounting to:

- ❖ LOT 1: One million (1,000,000) CFAF for lot 1 ;
- ❖ LOT 2: One million (2,000,000) CFAF for lot 2.

The bid bond will be automatically released no later than 30 days after the expiry of the validity of the tenders. Failure to provide a bid bond issued by a first-rate banking or financial institution approved by the Minister in charge of finance to issue bid bonds for public contracts, shall result in the outright rejection of the bid. A bid bond provided that has no relation with the Call for Tenders shall be considered as a failure to provide such bid bond.

A bid bond is deemed non-compliant:

- Which does not specify all the parties to the consortium, if applicable;
- Whose guaranteed amount is below the threshold required by the RPAO;
- Which involves a material error of such a nature as to call into question the expected legal effects.

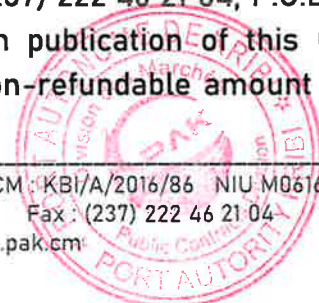
The stamped bid bond must be accompanied by a consignment receipt issued by the Caisse des Dépôts et Consignations (CDEC)

## 12. SUBMISSION OF BIDS

Each bid drafted in French or English in seven (7) copies among which one (1) original and six (6) copies marked as such must be received in hard copies no later than on 22 AVR 2025 at 12 p.m. prompt, local time at the following address:

In addition, the information in the financial file (price sub-details, unit price list, cost estimate) will be provided on a USB key during the bid-opening session.

Each bid shall bear the following mention:

"TO BE OPENED ONLY DURING THE BID-OPENING SESSION".

## 13. ADMISSIBILITY OF BIDS

Administrative documents, the technical file and the financial file must be placed in separate envelopes and submitted in a sealed envelope.

The Project Owner shall declare the following inadmissible:

- Envelopes bearing details of the bidders' identity;
- Bids received after the deadline for submission (date and time);
- Envelopes that do not comply with the principle of separation of administrative, technical and financial files;
- Envelopes that are not compliant with the submission mode (*as the submission mode is offline, all bids that are not submitted in hard copies under the terms specified in this Call for Tenders shall be declared inadmissible*);
- Bids that do not specify the Call for Tenders;
- Failure to comply with the number of copies indicated in the Special Rules of the Call for Tenders or bid submitted only in copies.





Any bid deemed incomplete as per the requirements of the Tender File shall be declared inadmissible, namely for the lack of a bid bond issued by a first-rate banking or financial institution approved by the Minister in charge of finance to issue bid bonds for public contracts or for failure to comply with the templates specified in the Tender File, shall result in the outright rejection of the bid. A bid bond provided that has no relation with the Call for Tenders shall be considered as a failure to provide such bid bond.

However, an administrative document, including the bid deposit, produced or delivered on the spot during the opening session of the bids is admissible

#### 14. OPENING OF BIDS

The opening of bids shall take place on ~~22 AVR 2025~~ at 1 p.m. prompt by the Internal Procurement Committee of the Port Authority of Kribi in the Conference Room of the PAK 2-storey building next to MEAO building in Kribi.

Bidders or their duly mandated representatives shall attend this opening session. Such representatives must be one person per bidder even in the event the bidder is a consortium.

Under penalty of rejection, administrative documents required must be provided in originals or certified copies signed by the issuing institution or the competent administrative authority in accordance with the provisions of the Specific Rules of the Call for Tenders. They must have been issued less than three (3) months before the original date of submission of bids or after the signing date of the Call for Tenders.

Any bid whose administrative file including the bid bond is deemed incomplete after the 48h deadline provided by the Committee shall be declared inadmissible.

#### 15. EVALUATION CRITERIA

##### A. *Eliminatory criteria*

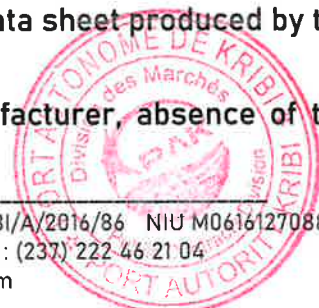
1) Insufficient number of copies (less than 7 copies)

2) Administrative file

- Absence of an administrative document when opening the bid;
- Non-compliance of an administrative file 48 hour after the bid-opening session ;
- False statement, fraudulent manoeuvre or forged document.

3) Technical file

- No catalogue brochure, drawing or technical data sheet produced by the manufacturer;
- In the event that the tenderer is not a manufacturer, absence of the





supplier's approval or authorisation issued by the manufacturer or no supplier's approval or authorisation issued by a dealer approved by the manufacturer accompanied by the dealer's approval;

- In the event that the tenderer is itself a manufacturer, absence of an authorisation or proof of carrying out its activity;
- Non-compliance with 80% of the technical specifications for supplies;
- Failure to meet 4 out of 5 essential criteria;
- No Integrity Charter initialled on each page, stamped, dated and signed;
- No declaration of commitment to comply with the social and environmental clauses initialled on each page, stamped, dated and signed;
- No declaration of commitment to pay customs clearance costs and all transport-related charges;
- No Supply Description (SD) initialled on all pages, stamped, dated and signed;
- No Specific Administrative Specifications (CCAP) initialled on each page, stamped, dated and signed;
- False statement, fraudulent manoeuvre or forged document.

4) Financial file

- No quantified unit price;
- No sub-details on quantified unit prices;
- False statement, fraudulent manoeuvre or forged document.

16. AWARD

The contract shall be awarded to the bid meeting all the technical and financial requirements and evaluated as the most competitive bid.

17. VALIDITY OF BIDS

Bidders shall be bound by their tenders for ninety (90) days with effect from the tender submission deadline.
